## June 2014 Board Meeting

- Board In-service was conducted by Emily Saed– MN Foundation for Student Organizations Director on board of director roles and responsibilities.
- We honored MN FCCLA’s National Officer– Olivia Wicklund, Litchfield and her adviser Julie Rick for their year.

### Board Mtg– New Business

Board passed a resolution welcoming MN HERO advisers to MN FCCLA. HERO is dissolving at the end of the state fiscal year. MN FCCLA will provide membership, STAR Events and leadership opportunities for members in occupational settings. Volunteers were sought for a transition task force to develop recommendations for decisions related to membership, STAR Events and leadership opportunities.

Board reviewed results from recent data collections of surveys of 600 STAR Event competitor students.

Adjustments were made to the existing financial procedures to clarify the balance of duties.

The calendar of event for the 2014-2015 year was reviewed.

The Board went into executive session for discussion about officer contracts and about the absence of two state officers at June Executive Council. Recommendations were made to handling this situation.
