## September board meeting topics

- Grant paperwork and reports have been done by staff for the 2012-2013 and 2013-2014 MN state grant, the C. Charles Jackson grant, and Lead State Agency report for Youth Service America. Notification has been received that MN FCCLA will be a Lead State Agency for GYSDAY in 2014.

- The "ASK Team" training for board members, state officers and advisers will be planned for Nov 4, 2013. Tammy Stanoch and Peter Noll will develop the training.

### Action taken

1. Chapters will have the opportunity for National Cluster Meeting in Omaha for November 22-24, 2013. Minnesota FCCLA WILL NOT be hosting a November Summit but request that Officers and Chapters consider attending the Cluster Meeting. Communication about ride sharing will be posted on the MN FCCLA website.
2. National STAR Events in San Antonio will increase in participation because states have two entries per category in 2014. The need for volunteers is urgent for each state to submit names of volunteers. MN FCCLA did not meet the quota in 2013. The board approved a fee be assessed to delegates attending national FCCLA conference but this will be waived if enough adult volunteers are provided by that chapter. Details of the fee will be in registration forms and the STAR Event Rules handbook.
3. A form for appealing the 7-Up membership party invitation will be developed for chapters to appeal their 7-up party invite. This will be part of state conference forms.
4. The Outstanding Chapter Recognition Form and award was reviewed and endorsed.
